She died about 1846 in Bond CO, IL, USA. He married (2) **CYNTHIA MARIAH MORRILL** on 22 Jul 1846 in Bond County, IL, USA. She was born on 28 Dec 1825 in VT. She died on 12 Jul 1896 in Pettis County, MO.

Oh yes, I have some old, old letters that were written to my great great grandmother, Mrs. Mary Ann Minerva West Cantrell, that were in my grandparents' possession and I got them last year. There is a letter written January 4, 1890 in Russelville, MO by "J. W. West" (John Warren West):

Dear Neace this is to inform you that I received your kind Letter of the first this instent was much pleased and gratifid to hear from you and will say that you are not mistaken in me Being your unkel for William Y West was my Brother that was killed in Dade County By the home gards or rather murders your Letter is the first scrach of a pen that I have had from Enny of your fathers Famley sense the wor and I don't know whare Enny of your famley Lives I will say that this Leaves me and my old Wife in common helth thoe we are nearly worne out for we have Bin waiting on ower yongest Daughter who is in the Last State of the Consupcion we hav Bin hear Ever sense the 12th of September I do sincerely hope that this may find you and yourn all will I have nothing of interest to write But will say that my Home is in La monte, Pettis County, Mo, But my self & wife is at ower sick Daughters in Monitau County 80 mildes east of ower Home the way I got your Letter I ordered the Post Master at La monte to remail my Letters to Russelville Cole Co, Mo we don't know how long we will have to stay hear But will go home as soon as we see how it will go with ower Daughter But I am sure She Caint Live much Longer unless a grate chaing I want you to write to me and Let me know how meney of your Father famley is yit A Live and whar thay Live I have just recivd a Letter from your Coson Mary West Brother Benjamin B. Wests Daughter thay Live at Siloam Springs Howel County Mo your uncle is verry pore helth I will say to you that out of ten children we only have three living Pricilla Stone ower oldes is Living in Jefferson City Cole Co, Mo, John J West ower only son Lives in La monte Pettis Co. Alzada Vanpoole the younges which is aflictid and whare we now one Lives near Russelville Monitau Co. But hir stay with us will be short without a grate Blessing of divine profidence.

I want you to write and all that you think would intesting us and inform us whare your Mother is and whare all of your Brothers & Sisters is that is yit Living if you write soon which I want you to do Direct your Letter to Russelville Cole Co., Mo.

You Must Excuse my pore writing for I have ben setting so much of nights and

loosing so much slepe and am old and trimbly that I cant hardly write if I Live to
See the 6th day of June next I will be 78 years old
So nomore at Present But remains your afectinet unkle until Death
